RULES AND PROCEDURES OF THE OPEN COMPETITION FOR THE PHD STUDIES (DOCTORAL) IN THE FIELD OF EDUCATION SCIENCE IN 2024

Admission to study at Kaunas University of Technology (KTU), Lithuanian Sports University (LSU), Vilnius University (VU) third cycle studies (doctoral studies) is carried out in accordance with the General Doctoral Regulation and the procedure for calculating the competitive score established in 2024.

- 1. The open competition for admission to the doctoral program in the field of educational science is open to persons with a master's degree or an equivalent higher education.
- 2. Admission is carried out to the places of general doctoral institutions in accordance with the quotas allocated annually by the Ministry of Education and Science (hereinafter referred to as the Ministry) (for each higher education institution separately).
- 3. The competition is conducted for individual topics of the General Doctoral Institution.
- 4. The applicant submits an application to the Rector of the General Doctoral Institution for permission to participate in the open competition for doctoral studies. This application shall be submitted to the department administering the doctoral studies of the Joint Doctoral Institution for which the theme is being applied for and where it is planned to prepare the thesis –KTU, the department administering the doctoral studies of the LSU. Other documents must be submitted along with the application, which specifies the direction, form and order of priority of the desired thesis topics (no more than two), (see paragraph 23).
- 5. Applicants with a master's degree in non-educational science or a higher education equivalent to it must additionally take the entrance exam in education. The exam is taken at the university where the application for admission to the doctoral open competition is submitted. The examination program is published on the university's website together with the rules and procedure for the open competition for the third cycle of study (doctoral studies) in the field of education science in 2024. Those who have passed this exam in a positive way continue to participate in the competition in the prescribed manner.
- 6. The competition for admission to a doctoral degree is organized by the Scientific Service of the coordinating university (Lithuanian Sports University), and is carried out by the General Doctoral Committee, which includes representatives of all educational scientists of all institutions that make up the joint doctoral studies KTU, LSU, VU. According to the procedure of the competition, applicants are admitted to the General Doctoral Studies in the field of educational science separately according to the topics proposed by the institutions. All applicants must appear for an interview with the members of the Committee.
- 7. With persons who are separately admitted by competition to permanent and part-time doctoral studies in the field of education science, the rectors of general doctoral institutions or their authorized persons sign bilateral agreements of the established form (the contract is signed with the rector of that university, where the dissertation will be prepared).
- 8. The selection criteria for an admission to a doctorate in 2024 are as follows:
 - scientific publications (the assessment takes into account their compliance with the direction of educational science, the chosen topics of research and dissertation);
 - scientific experience (the assessment takes into account the nature of scientific activity);
 - the weighted average of the evaluations of the postgraduate or single-stage higher education institution studies and thesis of the entrant;

- the grade of a foreign language (English, French, German) indicated in the supplement to the diploma of the first, second or single-stage higher education institution (optionally) or in the certificate issued by the licensed center for foreign languages;
- motivational conversation.
- 9. The selection criteria, their weight coefficients and the calculation of the competitive score on the recommendation of the Committee, on the recommendation of the Committee, shall be approved by order of the Rector of each institution of the Joint Doctorate every school year. 2024 See the procedure for calculating the competitive score. in Annex 1:
- 10. Based on the selection criteria, the Committee evaluates the applicants with scores and forms separate priority rows for general doctoral studies on the topics of specific institutions (KTU, LSU) according to the highest competitive score. Applicants who have scored at least 8 (eight) competitive points are admitted to state-funded study places.
- 11. On the basis of the committee's protocol, applicants for a doctoral degree are admitted by separate orders of the rectors of general doctoral institutions (KTU, LSU) depending on which higher education institution the applicant chooses the proposed topic and in which he will prepare the thesis, indicating the institution of general doctoral studies, the direction of science, the form of doctoral studies (permanent up to 4 years, or part-time up to 6 years), the nature of the funding, the topic of the thesis.
- 12. If there are vacant places after admission, the Scientific Service of the coordinating university may organize the second stage of admission, which is carried out in accordance with the same procedure.
- 13. Applicants who have not entered state-funded places by means of a competition may, on the proposal of the Committee, choose paid doctoral studies by paying the doctoral tuition fee set by the joint doctoral institution with which they will sign the contract.
- 14. Citizens of the European Union (hereinafter referred to as the EU) take part in the competition in a general manner.
- 15. Applicants who have obtained a master's degree or a diploma of equivalent higher education abroad, together with the documents referred to in point 23, additionally submit a document confirming the recognition of a qualification obtained abroad and pay the doctoral tuition fee established by the joint doctoral institution with which they will sign the contract.
- 16. Citizens of non-EU countries admitted to doctoral studies must obtain a residence permit in the Republic of Lithuania in accordance with the procedure established by legal acts.
- 17. Doctoral studies are held in Lithuanian or in a language approved by the Committee.
- 18. The Committee shall, not later than during the first two weeks of doctoral studies, organize a meeting(s) of the Committee, which shall be attended by newly admitted doctoral students and managers who have won a dissertation-topic competition; newly recruited doctoral students are appointed a manager.
- 19. On the recommendation of the committee, the rector of the doctoral institution approves the head of the doctoral student by order. On the recommendation of the department administering the doctoral studies of the institution, the rector by order approves the academic unit of the institution, to which the doctoral student is assigned.
- 20. The file of a person who has not been admitted to a doctorate is stored for a year in the Scientific Service of the coordinating university, and later in the archives of the coordinating university.
- 21. A person who has submitted a request to participate in a competition for admission to a doctoral degree and has not been accepted may, within two days of the publication of the minutes of the Committee:
 - 21.1. make a reasoned request or appeal to the Committee;
 - 21.2. after receiving a negative response from the Committee, within two days to submit an appeal to the rector of the coordinating university.

23. Documents submitted for admission to the doctoral program.

- application to KTU, or on behalf of the rector of LSU (depending on which institution the doctoral student chooses);
- two recommendations of scientists in the field of educational sciences with a habilitated doctoral or doctoral degree of science;
- curriculum vitae (handed in signed);
- the diploma of the master's degree or the diploma attesting to the corresponding qualification, its annex / appendix (the originals will be immediately returned) and copies of these documents (copies are served);
- a supplement to the diploma of the first, second or single-stage higher education institution (optional) or a certificate issued by a licensed center for foreign languages indicating the grade of a foreign language (English, French, German) (the originals are immediately returned) and copies of these documets (copies are served);
- a list of the research papers of the doctoral student (a full bibliographic description is provided) and their prints, if any (accompanied by copies of the cover and content of the publication); accepted works for the press are submitted with a certificate from the editor of

the publication about the accepted press article (after the review procedure); for those who have completed postgraduate studies in this calendar year, a copy of the master's thesis (if any);

- Certificates of presentations read, about work at scientific conferences, if any (copies are handed over; the originals will be immediately returned);
- one photograph measuring 3 x 4 cm (handed over);
- a copy of the receipt of the entrance tuition fees paid to the account of KTU or LSU in the bank or certified copies of documents proving the right not to pay the entrance tuition fee;
- documents confirming the change of name, if not all the documents submitted are under the same name (copies are served);
- a copy of the personal data page of the passport or a copy of the identity card (a copy is served).

- **5.** P assessment of the interview for admission to the doctoral program. It is evaluated in a ten-point system, following the logic of the assessment provided for by the CDM.

Criteria:

- a) the applicant is able to justify the motivation to study in this doctoral program;
- b) the applicant demonstrates accountability on the chosen theme.
