ON THE APPROVAL OF THE RULES OF ADMISSION OF FOREIGN STUDENTS TO FIRST AND SECOND CYCLE STUDIES OF LITHUANIAN SPORTS UNIVERSITY IN 2025

I. GENERAL PROVISIONS

1. The Rules of Admission of Foreign Students to First and Second Cycle Studies of Lithuanian Sports University in 2025 (hereinafter 'Rules') shall determine the general conditions of admission to the first and second cycle studies of Lithuanian Sports University (hereinafter referred to as the 'University') in 2025, as well as the specifics of the organisation and conduct of admission.

II. LIST OF STUDY PROGRAMMES

2. Enrolment of students in 2025 is conducted for the first cycle (bachelor's degree) programmes outlined in Table 1.

- 5. The data used to determine the competitive score shall be taken from the applicant's provided documents certifying the completion of the required education.
- 6. General principles for determining the competitive score for admission to the first and second cycle studies:
- 6.1. The marks of five-point system in the diploma supplement (annex) shall be doubled. The marks of systems other than the ten-point grading system shall first be converted to the ten-point grading system, and only then the competitive score shall be calculated.
- 6.2. If the supplement (annex) to the first cycle studies diploma does not specify the number of credits, the arithmetic mean of the marks in the supplement (annex) to the diploma shall be taken to determine the competitive score.
- 6.3. If in the supplement (annex) to the first cycle studies diploma a module has received a mark of 'pass', the mark and the credits shall not be counted in the calculation of the competitive score.
- 7. If the applicant's education documents were issued by institutions in foreign countries, the applicant shall only be admitted to the first and second cycle studies if his/her education is recognised in the Republic of Lithuania. The process of academic recognition of education acquired abroad is carried out at the University during the admission process, after the applicant has submitted the required documents in the University's Information System.
- 8. Foreign students who have completed the relevant study programmes and obtained a qualification degree but who have not studied the compulsory modules in the first cycle studies, or who have received a certificate from the specialist of academic recognition of the University's Studies Division

indicating that the acquired qualification can be recognised as equivalent to the professional bachelor's degree granted in the Republic of Lithuania, are obliged to take and pass the modules through supplementary studies (Table 2). A fee for the supplementary studies shall be paid by the students.

9. Foreign students shall complete supplementary studies simultaneously with their main studies or remotely until the end of the first semester of studies on 31 January 2026.

IV. CONDUCT OF ADMISSION

10. Conduct of admission. The admission to the first and second cycle studies is based on institutional admission.

11. Documents and application fee required for institutional admission:

- 11.1. Applications to participate in the institutional admissions competition (for non-state-funded study places only) shall be accepted on the dates confirmed in Table 4.
- 11.2. In the application form, the applicant's preferences shall be listed in descending order of priority (listing up to 3 (three) study programmes). The evaluation of the application and all admission procedures shall be initiated upon the applicant submitting the proof of the receipt of the application fee paid into the University's bank account.
- 11.3. Application fee for applicants from the Republic of Lithuania and other EU countries **50 EUR**, application fee for applicants from non-EU and EEA countries **200 EUR**. - 11.4. Once an application for admission has been registered, the application fee paid is non-refundable.
- 11.5. Application for admission shall be submitted together with electronic copies of the following documents:
 - Application form;
 - Passport copy (for non-EU/EEA citizens) or personal identity card copy (for EU/EEA citizens);
 - A copy of the secondary school graduation certificate and its supplement (annex) of marks (if issued); a copy of graduation diploma and its supplement (annex) of marks;
 - A copy of the application fee payment receipt;
 - Language proficiency certificate: IELTS 5.5, TOEFL iBT (0–120) 46–59 or equivalent foreign language test certificate proving B2 English language level. This requirement does not apply to foreign nationals who have completed their studies in English or have English as their first (native) language.
 - Curriculum vitae and a photograph taken on the day of the submission of the documents.

- 13. All EU/EEA and non-EU/EEA nationals shall be subject to a non-refundable deposit of 1,000 EUR, deducted from the tuition fee.
- 14. Non-EU/EEA citizens are obliged to pay at least one year's tuition fee to the University before being issued with the documents required to obtain the temporary residence permit (see Table 4). In the case of those who do not receive their temporary residence permit by 1 October, the tuition fee shall be refunded in full. In all other cases, the tuition fee shall be refunded with the deduction of the deposit of 1,000 EUR (the foreign transaction fee shall be paid by the student).

- 14.1. The request for a refund shall be submitted in the University's Information System, by e-mail or in writing no later than 10 October. If the student does not receive a response regarding temporary residence until 1 October, the student shall be allowed to study remotely for the first semester. After the first semester, the student may request his/her academic certificate and apply for a refund of the spring semester fee.
- 14.2. The request for a refund shall be accompanied by an official reply from the embassy refusing to issue the temporary residence certificate or temporary residence permit.
- 14.3. The request for a refund shall include the student's bank account number.
- 14.3.1. In the case that the request for a refund includes a bank account number of another person/institution or the refund is requested to be paid to an account other than the one from which the tuition fee was paid, the student shall write a statement (in free form) that he/she agrees to the transfer of the refund to the bank account of the other person/institution.
- 14.4. The request with attached required documents shall be submitted to the Study Division. The request shall be processed by the Study Division within 5 working days and may not be amended.
- 15. Tuition fees for enrolment in English-taught study programmes:

- 16. Citizens of the EU member states and EEA countries are obliged to pay at least one year's tuition fee no later than 1 September. In the event of Study Agreement termination after 1 September, the tuition fee shall be refunded, with the deduction of the deposit.
- 16.1. The request for a refund shall be submitted in the University's Information System, by e-mail or in writing no later than 10 October.
- 16.2. The request for a refund shall include the student's bank account number.
- 16.2.1. In the case that the request for a refund includes a bank account number of another person/institution or the refund is requested to be paid to an account other than the one from which the tuition fee was paid, the student shall write a statement (in free form) that he/she agrees to the transfer of the refund to the bank account of the other person/institution.
- 16.3. The request with attached required documents shall be submitted to the Study Division. The request shall be processed by the Study Division within 5 working days and may not be amended.
- 17. Foreign students shall only be granted accommodation for the first year of their studies, thereafter the possibility of living in the University's dormitory is considered according to the availability.

- 19. Other information. The procedures for the competition to the state-funded study places for foreign education holders are determined by the Ministry of Education, Science and Sport (applications for admission to the first cycle studies are submitted through LAMA BPO; applications for admission to the second cycle studies are submitted through the University's Information System). In all matters not provided in the Rules, the decisions shall be made by the admissions board appointed by the order of the Rector.
